

CATT PASSENGER RULES

1. **NO SMOKING, EATING OR DRINKING PERMITTED** on any Cheyenne-Arapaho Tribal Transit vehicle; however passengers may transport items if they are in secure containers.
2. **NO WEAPONS OF ANY KIND WILL BE TOLERATED ON ANY C-A TRANSIT VEHICLE.** Passengers will be subject to random checks by CATT staff, local and/or Tribal Law Enforcement/Security Officers.
3. **ACTUAL OR THREATENED PHYSICAL ABUSE IS PROHIBITED;** any single act will result in disallowed services.
4. **NO FREE RIDES** (unless otherwise advertised by CATT) – **DO NOT ASK.** A Bus Schedule should be referred to when determining the amount owed.
5. Passengers shall refrain from the use of **ABUSIVE OR PROFANE LANGUAGE;** **Profanity will not be tolerated.**
6. **Passengers** must wear seatbelts and keep hands/arms inside vehicle at all times.
7. **All passengers** must stand behind white or yellow line at either door of the bus. No standing or sitting on the bus steps.
8. **Passengers** must stay seated until vehicle comes to a complete stop.
9. **SHOES AND SHIRTS** must be worn. Dress attire that is inappropriate as defined by the governing law as indecent exposure is prohibited. No roller skates allowed.
10. **NO PETS:** service animals are the only exception to the rule.
11. **BUSES** are equipped with wheelchair ramps and lifts.
12. **MOTORIZED SCOOTERS** are permitted, however must be secured and passenger must sit in passenger seats.
13. **LARGE OBJECTS** that cannot be stored in lap or an available seat next to passenger without obstructing aisle or other passengers are not permitted.
14. **STROLLERS** must be folded and carried onto bus and secured while riding.
15. **All passengers** must be at least (18) years of age to board the CATT vehicle. Anyone under the age of (18) must be accompanied by an adult at all times.
16. **WHEN EXITING,** passengers are discouraged from crossing in front of the bus. They should always wait until the bus pulls away.
17. **SPECIAL NOTICE TO PASSENGERS:** The Cheyenne-Arapaho Tribal Transit Program is not responsible for lost or stolen items left in the vehicle. Please remove all your personal items when you depart.
18. **Alcoholic beverages** will not be allowed on any transit vehicle. Furthermore, if you are intoxicated or smell of alcohol, you will not be permitted to board any C-A tribal transit vehicle.
19. **ALL children/infants MUST be secured in proper restraints. For safety issues, parents must provide own car seats. If NOT properly restrained, we will be unable to transport.**
