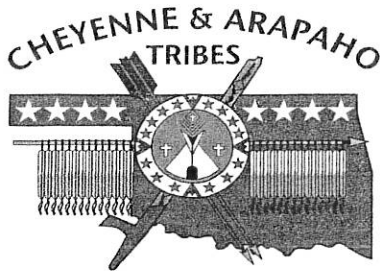

IF YOU INTENTIONALLY ATTACH THIS CHEYENNE-ARAPAHO TAG TO ANOTHER VEHICLE OTHER THAN THE VEHICLE THIS TAG IS REGISTERED TO, YOU SHALL BE PUNISHABLE BY REPOSSESSION OF OUR CHEYENNE-ARAPAHO TAG, A FINE, AND INDEFINITE TERMINATION OF OUR SERVICES.
