2022 Annual LEGISLATIVE Calendar of the NINTH LEGISLATURE (1-12) REGULAR SESSION DATES

The Constitution of the Cheyenne and Arapaho Tribes requires that the Legislature convene in Concho, OK for Regular Sessions. *Article VI, Section 6, subsection (a) of the Tribes Constitution reads in part: "The Legislature shall convene in Concho for twelve (12) Regular Sessions of up to two (2) consecutive days beginning on the second Saturday of each month beginning at 9:00 a.m."*

In addition, the Constitution of the Cheyenne and Arapaho Tribes requires that the Legislature shall adopt and follow a public Legislative Process for enacting all laws and resolutions. *Article VI, Section 7, subsection (a)(i-vi) of the Tribes Constitution reads in part: "All Bills shall be published in a Legislative Calendar for at least thirty (30) days prior to action on the Bill. All Bills shall be made the subject of a Public legislative hearing prior to action on the Bill."*
