SUBJECT: REMOVAL OF THE TRIBAL COUNCIL COORDINATOR

WHEREAS; The Cheyenne & Arapaho Tribes are a federally recognized tribe organized under a Constitution approved by the tribal membership on April 4, 2006 and approved by the Secretary of the Interior, and

WHEREAS; The Cheyenne & Arapaho Constitution Article V, Section 5 (a) states that A Coordinator for the Office of the Tribal Council shall be selected by the Tribal Council at the Annual Meeting of the Tribal Council or at a Special Meeting of the Tribal Council as needed. Members of the Tribes interested in serving in the position of Coordinator shall submit an application at least thirty days prior to the Tribal Council Meeting.

WHEREAS; On November 10, five members of the Seventh Legislature signed a resolution calling for a Special Tribal Council Meeting to remove the Tribal Council Coordinator to be held on December 15. The date the resolution was signed and the date of the meeting is only thirty-five days. In this brief time that the position was open only two candidates applied. Jennifer Plummer and Karen Michelle Bigfoot.

WHEREAS; On December 15, 2018 Karen Michelle Bigfoot was selected for the position of Tribal Council Coordinator however the Tribal Council feels this was an unfair selection considering the short amount of time the Coordinator position was advertised.

NOW THEREFORE BE IT RESOLVED that the Tribal Council of the Cheyenne & Arapaho Tribes hereby removes Karen Michelle Bigfoot as the Coordinator for the Office of the Tribal Council.
