RESOLUTION: A Resolution to authorize the submission of the application for the yearly Family Violence Prevention and Services Grant.

RESOLUTION NO. 9L-2022-0518-003

DATE INTRODUCED: May 12, 2022

SPONSOR: Travis Ruiz, A3 District

CO-SPONSOR: Diane Willis, A1 District

WHEREAS: The Cheyenne and Arapaho Tribes are a federally recognized Indian tribe organized pursuant to a Constitution approved by the tribal membership on April 4, 2006 and approved by the Secretary of the Interior; and

WHEREAS: Article VII, Section 4(d) of the Constitution requires that the Legislature or Tribal Council give prior authorization for the signing of the contracts by the Governor; and

WHEREAS: Article VI, Section 7(a) of the Constitution, the Legislative Process provides that all Bills shall be published in a Legislative Calendar for at least thirty days prior to action on Bill; and

WHEREAS: The resolution will be formally introduced at the next Regular Session of the Legislature, or at a Special Session of the Legislature requested by the Governor, Reggie Wassana; and

WHEREAS: The Legislature has the Constitutional obligation and public responsibility to the Tribes to oversee the Tribe's operations and identified the necessity to ensure governmental accountability and responsibility in government activities; and


WHEREAS: Children and families are critical to the Tribes and the United States Department of Health & Human Services Administration

WHEREAS: The primary goals of the Family Violence Prevention and Services Grant is to provide family violence prevention and services to tribal members and/or Native American families living in the tribal service area that are victims of violence.

WHEREAS: The Cheyenne and Arapaho Tribes Ninth Legislature finds that it is necessary and proper for the good of the Tribes to apply for the funding from the Health and Human Services.

NOW, THEREFORE BE IT RESOLVED: The Ninth Legislature of the Cheyenne and Arapaho Tribes hereby authorizes the submission of the grant application to Health and Human Services for the Family Violence Prevention and Services Grant.

BE IT FINALLY RESOLVED that the Ninth Legislature authorize Governor Reggie Wassana to sign and submit the grant application to Health and Human Services for the Family Violence Prevention and Services Grant.



Pursuant to Article VI, Section 7, subsection (a)(iv) of the Tribes Constitution reads in part: "All laws shall take effect thirty (30) days after signature by the Governor or veto override by the Legislature, unless any Member of the Tribes submits to the Coordinator of the Office of Tribal Council a petition signed by at least one hundred fifty (150) Members of the Tribal Council seeking to repeal the law or resolution at the next Tribal Council meeting. If the Tribal Council fails to repeal such law or resolution at the next Tribal Council where the matter has been properly placed on the agenda for the Tribal Council meeting, such law or resolution shall become effective immediately."

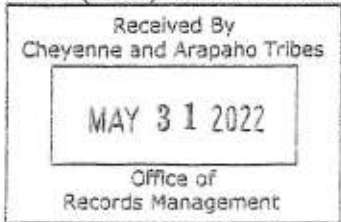
