SUBJECT: A Resolution to Amend 9L-RS-2022-06-001.

WHEREAS: The Cheyenne and Arapaho Tribes (the “Tribes”) are a federally recognized Indian tribe organized pursuant to a Constitution approved by tribal membership on April 4, 2006 and approved by the Secretary of the Interior on May 17, 2006 (the “Constitution”); and

WHEREAS: The Legislature has the Constitutional obligation and public responsibility to the Tribes to oversee the Tribes’ operations in order to establish and promote justice, establish guidance and direction for the government and advance the general welfare of the Tribes; and

WHEREAS: On June 11, 2022, the Ninth Legislature passed 9L-RS-2022-06-001, which was titled “A Resolution to Appropriate Net Revenue Loss Funds for the Cheyenne and Arapaho Housing Authority for home repairs in the 11-county service area”; and

WHEREAS: The final Resolution that passed included a contradiction in the final funding amount to be appropriated to the Cheyenne and Arapaho Housing Authority; and


WHEREAS: As set forth in the fifth *Whereas* on the Second Page, the funding amount was increased to a total of \$6.2 million from Net Revenue Loss funds; however, a separate paragraph did not include the increase and remained showing a request of \$3 million in Net Revenue Loss funds; and

WHEREAS: This Resolution is to amend the Resolution 9L-RS-2022-06-001 to correct the first *Whereas* of the second page, which requests \$3 million in Net Revenue Loss funds, and change it to \$6.2 million in Net Revenue Loss funds; and

WHEREAS: An additional amendment to Resolution 9L-RS-2022-06-001 is required as well to address the initial funding amount for Phase One of the project. Therefore, the passage of this Resolution will add the following language to 9L-RS-2022-06-001:

“The Cheyenne and Arapaho Housing Authority (“CAHA”) will be allocated \$900,000.00 from the Treasury Department from the total appropriated amount to begin the 3-phases. CAHA will keep track of expenditures and request additional Net Revenue Loss funds as the balance begins to get low. Supporting documentation will be provided to justify the additional funds”;

NOW, THEREFORE BE IT RESOLVED, that the Ninth Legislature of the Cheyenne and Arapaho Tribes amend Resolution 9L-RS-2022-06-001 with the recommended changes set forth above, which

Pursuant to Article VI, Section 7, subsection (a)(iv) of the Tribes Constitution reads in part: "All Bills passed by the Legislature shall be presented to the Governor for signature or veto. All laws shall take effect thirty days after signature by the Governor or veto override by the Legislature unless any Member of the Tribes submits to the Coordinator of the Office of Tribal Council a petition signed by at least one hundred fifty Members of the Tribal Council seeking to repeal the law or resolution at the next Tribal Council meeting. If the Tribal Council fails to repeal such law or resolution at the next Tribal Council where the matter has been properly placed on the agenda for the Tribal Council meeting, such law or resolution shall become effective immediately."

Pursuant to Article VII, Section 4, subsection (g) of the Tribes Constitution reads: "The Governor shall have the power to sign any enactment passed by the Legislature into law or to veto any enactment passed by the Legislature within ten days of passage with a written explanation of any objections; and if the Governor takes no action within ten days, then the enactment shall become law in accordance with this Constitution."
